The Course

The Justiceworks Half Marathon begins in Pfiffner Pioneer Park and travels east through Stevens Point's historic downtown, winding through the UWSP Campus, including a lake loop through Schmeekle Reserve. The course then travels north through scenic rural Stevens Point and turns west, following the east side of the Wisconsin River through beautiful Bukolt Park, along the Green Circle Trail and finishing at Pfiffner Pioneer Park.

The 5k race begins in Pfiffner Pioneer Park, travels north in an out and back course along the east side of the Wisconsin River through Bukolt Park and along the Green Circle Trail.
