## Runners

\$100 cash will be presented to each 1st place finisher in the open category (14-39) and overall masters (40+) category for both male and female in both the 5K and 10K races.

Age group awards will also be given in the following categories: 15-19, 20-24, 25-29, 30-34, 35-39, 40-44, 45-49, 50-54, 55-59, 60-64, 65-69 and 70 & over.

## Timing

The competitive run is bib-timed. We DO NOT use chip timing.

## Walkers

Walking is a non-competitive event. All walkers will be eligible to win door prizes.
