8. Terms of Participation

I know that running a road race is a potentially hazardous activity. I should not enter and run unless I am medically able and properly trained. I also know that, although police protection will be provided, there may be traffic on the course route and I must watch for vehicles at intersections and on the roads. I also assume any and all other risks associated with running this even including but not limited to falls, contact with other participants, the effects of weather including high heat and/or humidity and the condition of the roads. I recognize that if I choose to wear a portable listening device during the race that it may create a distraction which may increase my risk of injury. Dogs, inline skates and bikes are not allowed on the course. Runners or walkers with strollers must start in the rear. Knowing these facts, and in consideration of your acceptance of my entry fee, I hereby for myself, my heirs, executors, administrators or anyone else who might claim on my behalf, covenant not to sue, and waive, release, and discharge Justiceworks, Ltd. And any organization associated with the race, and the local governments and police, volunteers, and any and all sponsors, including their agents, employees, assigns or anyone acting on their behalf, from any and all claims or causes of action (known or unknown, foreseen or unforeseen) for death, personal injury or property damage of any kind or nature including those arising out of, their negligence in the course of, my participation in this road race and all other events and activities associated with this race. I give my permission for medical team evaluation, treatment and transfer to an emergency facility if needed. I agree that Justiceworks, Ltd. Race officials have the right to remove me from the race and related activities if they are of the opinion that it is in my best interest or the best interest of the event that I be removed. I further grant permission to Justiceworks, Ltd. And/or agents authorized by them to use any photographs, videotapes, motion pictures, recording, or any other record of this event for any purpose without limitation or compensation. I understand that fees are not refundable and race numbers and timing chips are not transferable. I agree to abide by the race instructions and understand that there is a three hour time limit after which the race course is not monitored by law enforcement associated with the event.
